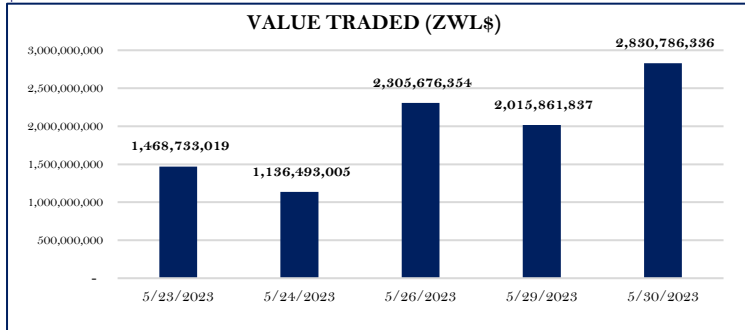

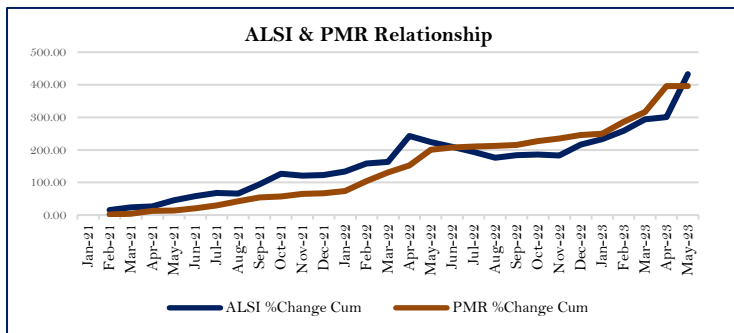
## MARKET SUMMARY

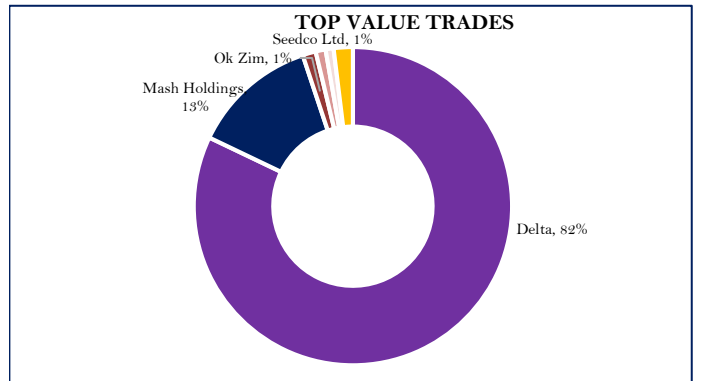
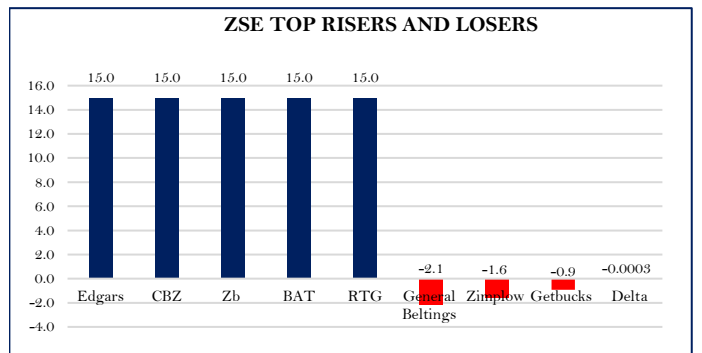
