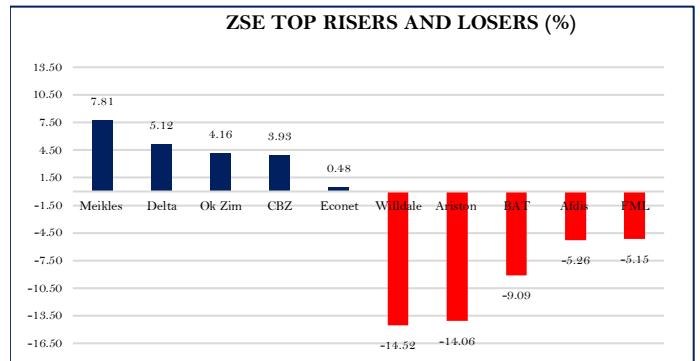
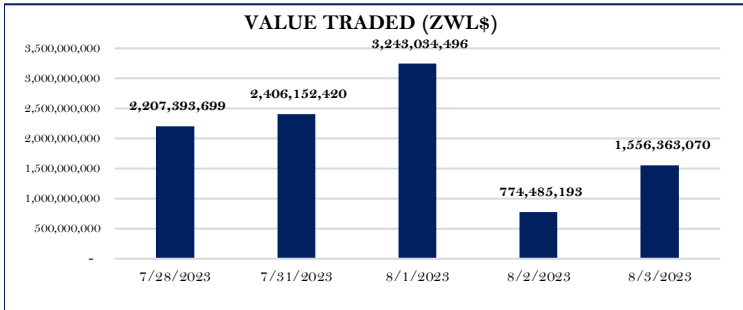

OK ZIMBABWE LIMITED (OKZ.zw) increased by \$4.9928 to \$124.9851 and ECONET WIRELESS (ECO.zw) traded \$2.4218 higher at \$502.9541.

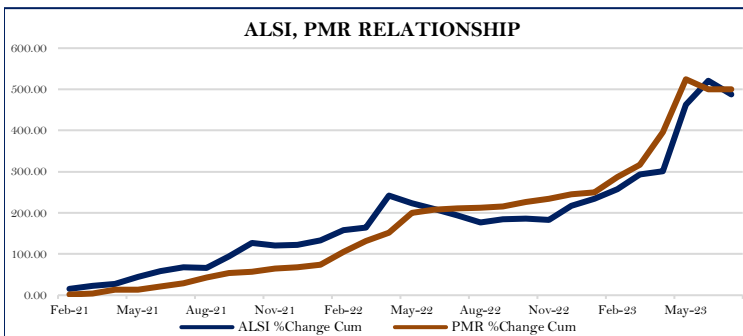
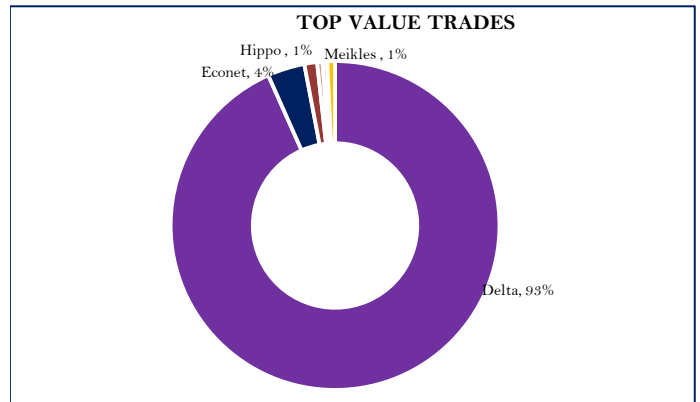
