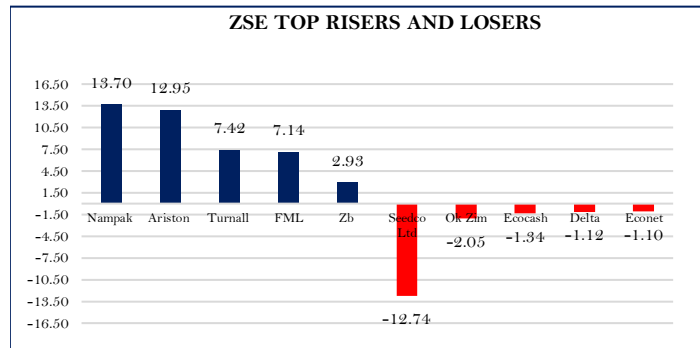
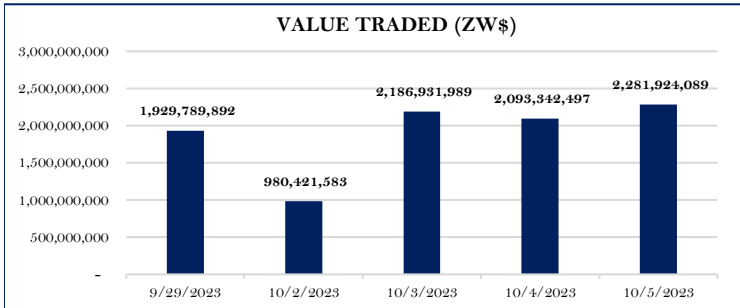

MARKET SUMMARY

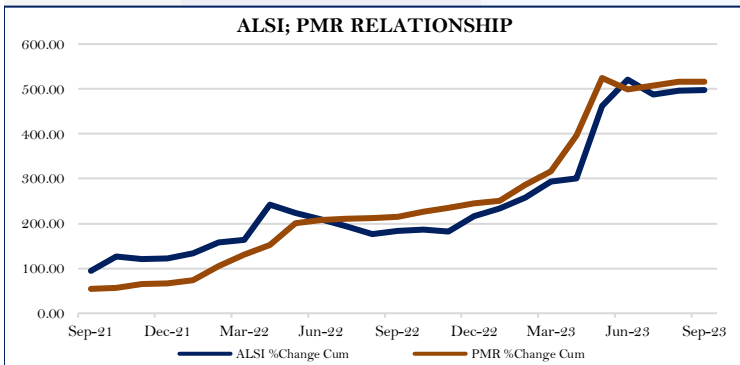
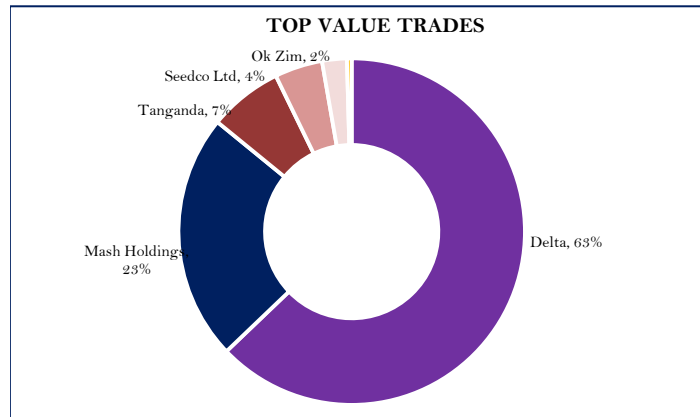
