DELTA CORPORATION LIMITED (DLTA.zw) gained \$25.8981 to close at \$2528.2385, HIPPO VALLEY ESTATES LIMITED (HIPPO.zw) was \$13.2333 up at \$1835.83333 and FIRST MUTUAL HOLDINGS LIMITED (FML.zw) added \$13,000 to \$585,000.
